The goal of this get together is to give legislators draft legislation bought and paid for by corporate special interests, away from the prying eyes of voters,

which benefit the rich and powerful. Corporations will have a chance to wine and dine these politicians, promise those fat contributions and a taste of the good life in exchange for supporting bills that keep

paychecks low, corporate welfare high, and restrict the rights of their political enemies.

CWA Mobilization at CPUC Hearings Spurs an Agreement with Frontier Effective with the Acquisition of Verizon

The California Public Utilities Commission (CPUC) under the direction of Commissioner Catherine Sandoval convened several public participation hearings regarding the acquisition of Verizon landline residential customers by Frontier Communications. CWA was present and participated at hearings on July 6th in Garberville, Ca, July 7-8 in Hoopa, CA, July 8th in Orleans, CA, July 20th in Rancho Mirage, Ca, July 21st in Claremont, CA, July 27th in Santa Clara, Ca, August 10th in Long Beach, CA and August 11th in Santa Barbara, CA. Vice President Tom Runnion testified at the hearing in Garberville.

In addition, CWA Staff, Staff Representative Judy RaPué, Area Director Ellen West as well as Assistant to the Vice President Ameenah Salaam gave relevant testimony at the other public participation hearings.

CWA Members from Verizon Locals, AT&T Locals and Sectors came out to support. CWA packed each hearing with more than the goal of 50 members and supporters at each hearing. Rancho Mirage, Long Beach and Santa Barbara were packed to standing room only. Below

are pictures from the Claremont, CA hearing held on July 21st. Kudos for the great turn out from members of Local 9588 and other CWA locals.



CWA not only provided testimony but more than 150 current pictures of Verizon's neglected plant which quickly became a topic for the participation hearings along with site visits. As quickly as the pictures where being submitted, Verizon was in the field fixing the plant. This overall mobilization plan helped us reach a tentative agreement with Frontier which provides for job security, increased wages and benefits for all members that will be acquired by Frontier.



On the left is a picture of the CWA supporters who attended the July 20th CPUC Public Participation Hearing in Rancho Mirage, CA. Approximately 73 CWA members from Locals 9586, 9400 and additional family members showed up in "CWA Red" to support the Verizon workers and families that would be affected by the sale of Verizon to Frontier Communications.

To the right is a picture of the turnout at the Hearing in Santa Barbara. There were between 50 to 60 members and family who joined CWA at the event from Local 9575, 9003, 9408 and UPTE 9119.

CWA District 9 Vice President Thomas Runnion said, "After several months of complex negotiations, we have reached an agreement that is in the best interest of telecommunications workers and consumers in California. As we move forward in this partnership with Frontier, CWA members will continue to provide customers with the quality service they expect and deserve.
