# SAVE THE DATE V APRIL 9, 2016

Locals across District 9 will be mobilizing leading up to this date, and beyond if necessary. Together, we can make sure the company will take our bargaining priorities serious. We must be ready to whatever is necessary to achieve a fair contract. We must prove <u>It's Our Turn</u>!

# **UNITY IN DISTRICT 9**



After several consecutive months of discussion at our CWA / AT&T Unit Meetings, discussing an issue that has remained for way too many years a source of division between the Locals across District 9, we made a historic consensus. Initially, it appeared that the months of discussion would be for not, and that the desire to unify our Locals on the issue of minimum strike duty to be eligible for CWA Member Relief Fund \*MRF monies on the 15<sup>th</sup> day of a strike would go down in flames. Then it happened... one by one, Locals began to compromise either raising our lowering their minimum picket duty requirements so that for once, we will have a single minimum picket duty requirement throughout District 9!

Regardless of which Local you belong to, every member in District 9 will need to serve a minimum of 16 hours of picket duty in order to be eligible for MRF monies on the 15<sup>th</sup> day of a strike, should one occur.

Why is this important? Because this will be the first time in a very long time, if not ever, that we will not have members upset that they are doing more than another member in a different Local for the same benefit. It is about practicing what we preach... **SOLIDARITY, UNITY, WORKING TOGETHER!** 

Will we need members to help beyond the minimum requirement of 16 hours? <u>Absolutely!!!</u> And we will certainly need to make sure that if a Local is well covered, we may be able to loan members to help out in neighboring Locals where they may need assistance. We must work together, and should a strike occur, <u>we must work together to win!</u>
